



BYLAW RATIONALE STATEMENT

Village of Silverton Bylaw 546, 2024 *"Water Rates and Regulations Amendment"*

Under the authority of the Community Charter, the following is a statement respecting Council's reasons for adopting *Village of Silverton Water Rates and Regulations Amendment Bylaw No. 546, 2024*.

This bylaw provides rates and charges for connection to the Village of Silverton Water System and establishes rates and charges for the use of the water from the Water System.

WATER RATES AND REGULATIONS AMENDMENT

Being a bylaw to amend the *Village of Silverton Water Rates and Regulations Bylaw No. 479, 2012*

The Council of the Village of Silverton, in open meeting assembled, **HEREBY ENACTS AS FOLLOWS:**

1. CITATION

This Bylaw may be cited for all purposes as "*Village of Silverton Water Rates and Regulations Amendment Bylaw No. 546, 2024, amending Village of Silverton Water Rates and Regulations Bylaw No. 479, 2012.*"

2. WATER RATES

The Schedule "A" of the *Village of Silverton Water Rates and Regulations Bylaw No. 479, 2012* is hereby replaced as follows:

Single Family Residence	\$637.00
Apartments, Suites or Duplexes, each unit	\$637.00
Bed and Breakfast, up to one room	\$637.00
In addition, each room/unit	\$78.00
Hotel, Motel, each cabin rental unit	\$637.00
In addition, each room/unit	\$78.00
Restaurant, Coffee Shop	\$977.00
Commercial Business	\$768.00

3. OTHER CHARGES

Service Connection Charge	\$1,346.00
