BEING A BYLAW OF THE VILAGE OF SILVERTON TO AMEND BYLAW NO. 493-2016, SCHEDULE A GARBAGE RATES

WHEREAS pursuant to Section 8 (3) (a) of the Community Charter Council may regulate, prohibit and impose requirements with respect to municipal services;

AND WHEREAS the Council of the Village of Silverton has established a garbage collection service as a municipal utility;

AND WHEREAS the Council of the Village of Silverton has adopted ByLaw No. 433-2005 for that purpose and deems it necessary to amend Schedule "A", the garbage collection rates;

AND NOW THEREFORE the Council of the Village of Silverton in open meeting assembled, enacts as follows;

1. That this Bylaw be cited for all purposes as "Village of Silverton Garbage Rates and Regulations Amendment ByLaw No. 499-2016."
2. Schedule "A", Fees and Charges is hereby replaced as follows.


3. Garbage Rates

Single Family Residence	\$	117.00 annual rate
Hotels and Motels	\$	276.00 annual rate
Restaurants, Coffee Shops	\$	276.00 annual rate
Commercial Business	\$	276.00 annual rate

Institutional	\$	276.00 annual rate
Church	\$	117.00 annual rate

4. That this Bylaw shall come into force and take effect as of and from the date of final adoption.

WHEREAS pursuant to Section 8 (3) (a) of the Community Charter Council may regulate, prohibit and impose requirements with respect to municipal services;

AND WHEREAS the Council of the Village of Silverton has established a water supply and distribution system as a municipal utility;

AND WHEREAS the Council of the Village of Silverton has adopted ByLaw No. 479-2015 for that purpose and deems it necessary to amend the water rates;

AND NOW THEREFORE the Council of the Village of Silverton in open meeting assembled, enacts as follows;

1. That this Bylaw be cited for all purposes as "Village of Silverton Water Rates and regulations Amendment ByLaw No. 498-2016."

2. Schedule "A", Fees and Charges is hereby replaced as follows.

3. Water Rates

Single Family Residence	\$	457.00 annual rate
Apartments, each unit	\$	457.00 annual rate
Bed and Breakfast, each room	\$	47.00 annual rate
Hotels and Motels	\$	457.00 annual rate
each room	\$	47.00 annual rate

Restaurants, Coffee Shops	\$	737.00 annual rate
Commercial Business	\$	574.00 annual rate

4. Service Connection Charge \$ 550.00
