EVACUATION ALERT RESCIND

The Village of Silverton has been advised that the potential threats to people and property in the Village of Silverton posed by the Aylwin Creek Wildfire (now named the Komonko Creek Wildfire) has diminished at this time.

The **Evacuation Alert** issued for the below area by the Regional District of Central Kootenay Emergency Operations Centre (EOC) is no longer required and is **RESCINDED** effective immediately for the entire Village of Silverton, including the following one-hundred eighty-five (185) properties (see attached map):


