ANALYSIS SUMMARY:

The 2021 Village of Silvertown By-Election was held in Silvertown on June 19, 2021 for the position of one Mayor. In accordance with the *Local Government Act*, the Chief Elections Officer, Sonya Martineau, is submitting the required ballot accounts report to Council for information.

BACKGROUND:

Local government elections are managed by the Chief Election Officer as appointed by Council. For 2021, a by-election was required to be held in the Village of Silvertown following the resignation of former Mayor, Jason Clarke, and the untimely passing of former Councillor, Kerry Gordon. The position of Councillor was acclaimed by Clarence Denbok, negating the need for an election by voting for that position. General voting day for the 2021 by-election for the position of Mayor was held in Silvertown on Saturday, June 19, 2021.






