



BYLAW RATIONALE STATEMENT

Village of Silverton Bylaw 545, 2024 *"Garbage Collection and Disposal Amendment"*

Under the authority of the *Community Charter*, the following is a statement respecting Council's reasons for adopting *Village of Silverton Garbage Collection and Disposal Amendment Bylaw No. 545, 2024*.

This bylaw establishes rates for the collection and disposal of solid waste.

GARBAGE COLLECTION AND DISPOSAL AMENDMENT

Being a bylaw to amend the *Village of Silverton Garbage Collection and Control Bylaw No. 433, 2005*

The Council of the Village of Silverton, in open meeting assembled, **HEREBY ENACTS AS FOLLOWS:**

1. CITATION

This Bylaw may be cited for all purposes as "*Village of Silverton Garbage Collection and Disposal Amendment Bylaw No. 545, 2024*, amending *Village of Silverton Garbage Collection and Control Bylaw No. 433, 2005*."

2. GARBAGE RATES

The Schedule "A" of the *Village of Silverton Garbage Collection and Control Bylaw No. 433, 2005* is hereby replaced as follows:

Single Family Residence	\$176.00
Apartments, Suites or Duplexes, each unit	\$176.00
Bed and Breakfast	\$365.00
Hotel, Motel, each cabin rental unit	\$365.00
Restaurant, Coffee Shop	\$365.00
Commercial Business	\$365.00
Dental Clinics	\$365.00
Institutional	\$365.00

3. SEVERABILITY

If any portion of this Bylaw is found invalid by a court of competent jurisdiction, the invalid portion is severed without effect on the remaining portions of this bylaw.
